ADMINISTRATIVE HISTORY/BIOGRAPHICAL SKETCH:

The Canadian Association of Distance Education (CADE) is a non-profit, volunteer based organization that aims to advance and promote distance education nationally, advance research in distance education, provide services, information, theory and practice and materials to its membership based on need, and to represent Canada and distance education on an international level. CADE is a bilingual organization (Association Canadienne de l'Education a Distance ACED, French counterpart), which is sustained by a Board of Directors along with membership and planned activities and conferences.

Margaret Haughey became the President of CADE during the 1991 election and nominations. Members of the board are volunteers who have an interest and expertise in higher and distance education. Prior to becoming President, Haughey was a long time active member of CADE and an advocate of distance education. At the time of the Presidential election, Haughey was an Associate Professor and Coordinator of Distance Learning in the Faculty of Education at the University of Alberta, in Edmonton, Alberta. By the time Haughey was elected, CADE was a national organization that had grown from 13 original members in 1983 to 639 members in 1992. Programs and services offered by CADE consist of *The Journal of Distanced Education*, *Communique* newsletter (which is sent to all members), professional development, research, an annual conference held in Canadian cities, government relations and external liaison.

While in her two year term as President of CADE, Haughey oversaw CADE's operational activities including conferences, finances, meetings and partnerships with other organizations and institutions including the International Council for Distance Education (ICDE) and the Center for Education Research and Innovation (CERI), among others. While Haughey was President, CADE reached its 10th anniversary, unveiled a new logo and produced conferences and workshops on distance education. Following her term as President, Haughey remained active in CADE, still attending conferences and helping her successor, Therese Lemy, during her presidency.

By 1998 Haughey was the Editor of *The Journal of Distance Education*, a journal produced by CADE. While Editor, Haughey applied on behalf of the journal for the Aid to Research and Transfer Journal Award, which the journal won. Haughey also worked on getting the journal published in EBSCO.

SCOPE AND CONTENT:

Fonds consists primarily of textual records related to Margaret Haughey's time as President of CADE and as Editor of *The Journal of Distance Education*. The textual records include various materials including faxes, emails, correspondence, hand-written notes, business plans, financial records, agendas, minutes, and agreements pertaining to the Board of Directors, the CADE newsletter, conference materials for conferences given by CADE or attended by Margaret Haughey, financial reports, statements and budgets, agendas and minutes from Board of Directors meetings, agreements between CADE and other organizations and institutions, and, strategic plans for CADE.

Included are drafts of official CADE documents, issues of *The Journal of Distance Education* and *Communique* (the CADE newsletter), correspondence and memos pertaining to *Communique*, correspondence, memos and plans relating to CADE's 10th anniversary, articles pertaining to distance education, Presidential messages from Haughey and other CADE presidents, and notices and information regarding the position of Secretariat.

Also included are audio cassettes from a CADE National Workshop lecture by Rosemary Brown on post-secondary education and Support Systems in Distance Education. Also contained within the fonds are a poster from a CADE annual conference held at Athabasca University, and a photograph of Dr. A.W. (Tony) Bates.
