ADMINISTRATIVE HISTORY:

The Colinton Literary Society existed in the 1930s in Colinton, Alberta and was created with the objective of providing wholesome enjoyment for members, and to help any causes it saw as worthy in the community. Society meetings were held every other Tuesday at 8:30 pm and Society membership was decided at the meetings. New members were proposed and seconded, then decided by ballot of already existing members. The membership fee was set at 50 cents per annum.

For any Society business to be passed, at least fifty percent of the members had to be present at the meeting. Members who missed more than three consecutive meetings were no longer considered members, unless due to unavoidable causes and approved by the President. The President of the Society had the authorization to call special meetings. The funds of the Society were to be at the disposal of the Executive Officers and all cheques were signed by the President and Treasurer.

The Society was known for presenting plays and productions. On February 24th 1933, the Society presented "George in a Jam," followed by a dance and a supper. A large number of members of the Colinton community attended the event.

Some members of the Society between 1935 and 1938 included; Miss Jones, P. Pristall, Mr. Hay, Angus Hay, Ralph Gibson, J.M. Jeanhash, M and J Talpash, Jon Hay, Miss Everett, D.D. Hay, H. M. Jays, N.O. Jack, E. Mitchell, G. Brocher, Rev. T.D. Jones, P. Crystal, R. Roxbourgh, H. Skar?, A Hay, H. Gyte and N. Huberdean, N.O. Jack was Treasurer of the Society. N.O. (Norman) Jack owned the Colinton garage, car dealership and lumberyard.

CUSTODIAL HISTORY:

The materials were donated by Bernard Wiese to the Thomas A. Edge Archives & Special Collections at Athabasca University in 2007. Wiese received the materials from Malcolm and Francis Roberts. It is unclear how the Roberts family came into possession of the items from the Colinton Literary Society.

SCOPE AND CONTENT:

Fonds consists of materials related to the Colinton Literary Society and its operation, finances and membership. Textual records include: a notebook containing records of receipts and expenditures, a receipts book, a copy of the society's constitution, an envelope addressed to No. Jack Esq., notes, shipping agreements, a letter from the Imperial Bank of Canada to No. Jack Esq. and receipts.
