Overview

A variety of works by Canadian, British, and American women will be studied, including three novels (*Jane Eyre*, *Wide Sargasso Sea*, and *Ravensong*); a play by Caryl Churchill; poetry by Adrienne Rich, Emily Dickinson, Sylvia Plath, and Bronwen Wallace; and essays by Adrienne Rich and Virginia Woolf.
