## 3. REPORTS

#### 3.1 Report of the Chair

The Chair presented this item noting there are no updates regarding the Investment Management Agreement from the Government of Alberta but if further consultation of GFC is required a special meeting will be called.



#### Discussions held on:

- federal supports for provincial post-secondary institutions
- declining enrolment and the approach to increase enrolments in the coming months
  including enhanced marketing and the ways that the Integrated Learning Environment
  (ILE) may address gaps and increase enrolments
- increasing costs of tuition and the impacts it could have on students accessing financial aid
- barriers Indigenous learners face obtaining access to AU and noted connecting with First Nations Education Authorities to promote AU and its offerings

#### 4. ACTION AND DISCUSSION ITEMS

#### 4.1 Motion 76-02

That the General Faculties Council approves the Master of Science in Earth System Science, effective July 1, 2023, or thereafter at the discretion of the Provost and Vice President Academic, subject to the approval of the Board of Governors and Alberta Advanced Education.

#### Clark/Perrin

The Dean, Faculty of Science and Technology and Associate Dean, Student Experience presented this item.

#### Discussions held on:

- funding requirements
- potential opportunities for industry partnerships
- potential for laddering in from undergraduate programs at AU including creating pathways and micro-credentials and collaboration between faculties
- inclusion of the new Indigenous Research Methodology course once opened
- tuition breakdown and how costs are inline with other post-secondary institutions
- differentiation between research projects or thesis and the credits assigned
- workload implications for graduate student supervision
- cost associated with the program and attracting thesis students
- inclusion of Indigenous themes into the program and encouragement of Indigenous Peoples to enrol in this program

The Chair and Provost and Vice-President Academic noted this program proposal would be presented to the Board of Governors Finance and Property Committee and the Board of Governors at the January 2023 meetings.

The Chair/Program Administrator, Nukskahtowin presented this item noting:

- the opening of the Linda Bull Memorial Garden and the Bertha Clarke Jones Gallery of Indigenous Art on September 27, 2022, which had a good turnout of family members, staff and community members
- the recently held children's feast will be an annual event
- the Bertha Clark Jones Gallery of Ingenious Art features the works of Terry Lusty who has displayed photographs of the Truth and Reconciliation Committee
- event photos were captured by Indigenous photographer Curtis Cameron and will be made available online
- an article from the Four Seasons Speakers Series will be published later this month
- meetings are continuing with the Deans, Vice Presidents on Indigenous Research at AU and discussions have included how the Nukskahtowin website will interact with faculty and departmental websites
- the next Strategic Planning session on November 21<sup>st</sup> is on Including Indigeneity in the AU Community. The session will begin a review and renewal of the Nukskahtowin Plan.

# 4.3 Research Status and Strategy Brief

The Associate Vice-President, Research presented this item noting grand writing development support being offered has been well received and members seeking REDCap training can reach out to the Associate Vice-President, Research.

# 4.4 Strategic Issues

## 4.4.1 Strategic Enrolment Management (SEM) Plan Progress Report

The Provost and Vice-President Academic and Deputy Provost, Academic Operations presented this item noting:

- the difficulties for AU to find comparatives in the Canadian market and the difficulty in obtaining national data on the adult learner market unlike market data that is available in international markets
- the pandemic period demonstrated both increases and declines in enrolment

#### Discussions held on:

- obtaining data from AU learners instead of seeking data from comparative markets
- tracking of visiting students and the importance of retaining them as AU learners
- building community for learners through cohort building and integrating professional development
- increasing learner support through reach outs, communications, connecting learners to opportunities and connection to their instructors
- increasing marketing activities to reach lifelong learners including career fairs and the development of PowerED courses to entice learners to enrol at AU
- finding the right mix to allow the university to take control of enrolment



- making courses more accessible including neurodivergent ratings and assessment for learners
- implementing "badges" for learners as they progress through courses
- providing education support for newcomers to Canada

The Provost and Vice-President Academic informed members the discussions and points raised would be taken away to explore how to integrate some of the ideas into the SEM plan and to determine how to best report to GFC on a more regular basis.

# 4.4.2 Roundtable (*identification of emerging academic issues to be discussed at future GFC meetings*)

The Chief Governance Officer and General Counsel noted work continues with finalizing the GFC Workplan and it will be presented to GFC Executive Committee at its January meeting. It was also noted an update on the Land Development and Real Estate plan will be presented at the January 31, 2023 GFC meeting. It was asked if the Land Development and Real Estate plan was giving consideration to returning land to the Indigenous Peoples. The Vice President Finance and Performance Services to follow up with the consultant on this matter.
