

# **Publication of Research Policy**

## Department Policy Number

#### Effective Date

September 25, 2002

#### Purpose

Athabasca University supports the principles of academic freedom and free access to the results of University research. Therefore, University research which is pursued under conditions that restrict publication, either in terms of content or beyond the limits specified in this policy, is not compatible with University policy.

#### **Definitions**

#### Policy

1. Publication of Sponsored Research

General

- I. Since the dissemination of research results is a primary function of Athabasca University, all sponsored research grants and contracts administered by the University shall be such that results obtained may be freely published, subject only to Sections 2.0 (Confidentiality) and 3.0 (Deferment of Publication), below.
- II. Acknowledgment of financial support by the sponsor shall normally be made in all publications.
- 2. Confidentiality
  - I. The University may accept a contract for research involving confidential data, provided that the results of the research may be published in a form that preserves the confidentiality of the data. Policy relating to the confidentiality of human subjects is set out in the University's <u>Policy on Research Involving Humans</u>.

- 3. Deferment of Publication
  - I. The University expects that research results will normally be published without any time restriction. However, sponsors of research grants or contracts may request or require delays in publication of research results for a period of no more than 12 months from the date of submission of the final report to the sponsor. Delays in publication at the request of a sponsor are permissible only if the public interest is best served by such delays, or if patent or similar protection is being sought.
  - II. Exceptions to the 12-month limit must be approved by the Associate Vice-President, Research and reported to Athabasca University Academic Council annually. Such deferment shall not exceed 24 months.
  - III. No restriction shall prohibit or delay the use of research results by students for theses or for other academic requirements of their programs.
